**I. SUMMARY OF INTERIM APPLICATION**

Larkins Vacura LLP ("Larkins Vacura"), having performed professional services as litigation counsel for Michael Grassmueck (the "Receiver") submits this First Interim Application for Professional Compensation ("this Application") for the period June 30, 2009 through and including February 28, 2010 (the "First Interim Period"). The Receiver and Larkins Vacura respectfully request the Court to enter an order pursuant to paragraph IV of the "Report of Receiver Regarding Summary of Legal Fees and Expenses, total Aggregate Value of Property Recovered, and Proposed Counsel to Pursue Third Party Claims" (dkt. 173) ("the June 25, 2009 Receiver's Report") and this Court's Order dated June 29, 2009 approving the Receiver's retention of Larkins Vacura (dkt. 178) ("Appointment Order") allowing Larkins Vacura's interim compensation for services rendered and expenses incurred during the First Interim Period in the amount of \$66,118.00 in fees and \$5,107.62 in costs.

For the reasons described below, Larkins Vacura requests this Court to approve its Application based on the bills attached hereto as Exhibit A and the summary attached hereto as Exhibit B. Consistent with the Appointment Order, the blended rate billed by Larkins Vacura during the First Interim Period is \$258.58, below the \$300 per hour maximum ordered by the Court.

Detailed descriptions of legal services rendered, billed in increments of one-tenth of an hour, are contained in the invoices attached hereto as Exhibit A. A summary of each timekeeper's hours, billing rate, position and year of experience is attached hereto as Exhibit B.

## **II. LARKINS VACURA'S SELECTION AS LITIGATION COUNSEL TO RECEIVER**

The June 25, 2009 Receiver's Report discussed the Court's request for a proposal by the Receiver to handle the Third Party Litigation at a blended rate of \$300 per hour; recommended that the Court approve the Receiver's retention of Larkins Vacura to pursue the Third Party Litigation; and included a statement of the background and qualifications of Larkins Vacura. In the Appointment Order, this Court approved the Receiver's recommendation.

## **III. SUMMARY OF WORK PERFORMED BY LARKINS VACURA DURING FIRST INTERIM**

Following the Court's June 29, 2009 Appointment Order approving Larkins Vacura as counsel for the Receiver for the purpose of pursuing certain third-party claims against Stephen Bishop ("Bishop"), Russell DeVan ("DeVan"), Lawrence Madoff ("Madoff"), Ingrid Murro Botero ("Botero"), Douglas Oberan ("Oberan"), Yada Schneider ("Schneider"), and various business entities associated with these parties, Larkins Vacura undertook this representation and began investigating these parties and their potential assets. On October 26, 2009, the Receiver filed a fraudulent transfer action in federal district court for the District of Oregon against all of

the defendant individuals, with the exception of Oberan, and all of the defendant entities associated with these individuals, including Oberan's entities, that were involved or otherwise connected with Global Online Direct, Inc. This action is titled *Grassmueck v. Bishop, et al.*, Case No. CV09-1257-HU (hereinafter referred to as "the Bishop action").

Oberan was not named in the Bishop action because he filed for Chapter 13 personal bankruptcy in Arizona in August 2009. This action is titled *In re Oberan*, Case No. 2:09-bk-18888-EWH (hereinafter referred to as "the Oberan action"). Larkins Vacura filed an objection to Oberan's bankruptcy plan on behalf of the Receiver on September 28, 2009, and thereafter requested and received document and testimonial discovery from Oberan. Following a thorough review of these materials, the Receiver, with the assistance of Larkins Vacura, filed a notice of claim in the Oberan action in the amount of \$ 3,182,795.15. In response to the Receiver's claim, the bankruptcy trustee for the Oberan action recently filed a motion to dismiss or convert the case to another chapter because Oberan is not qualified to seek Chapter 13 bankruptcy relief.

In the Bishop action, Larkins Vacura undertook to serve each of the defendants. Despite numerous conversations between Larkins Vacura and Madoff's attorney, Madoff is actively avoiding service, and, on February 9, 2010, Larkins Vacura moved the Oregon court for leave to serve him by publication. The court granted this motion, and Larkins Vacura has made arrangements for publication pursuant to the court's order. All of the remaining defendants in the Bishop action have been successfully served.

The individual defendants in this action are appearing pro se and they also attempted to represent their respective entity defendants on a pro se basis. Following numerous and repeated requests to the court, however, the entities were ordered to participate in the litigation only through counsel. They have all failed to do so. Therefore, acting on behalf of the Receiver,

Larkins Vacura moved for entry of default against four of the five entity defendants, which were granted by the court. Larkins Vacura is now in the process of seeking entry of default against the one remaining entity defendant and seeking entry of judgment against these parties.

Three of the four individual defendants who have been served—Bishop, DeVan, and Schneider—have each filed motions to dismiss for lack of personal jurisdiction. The Receiver, through the assistance of Larkins Vacura, prepared and filed an opposition to each of these motions, and, pursuant to court order, also filed a surreply to DeVan and Schneider’s motions addressing specific evidentiary objections raised by these pro se parties. The remaining individual defendant who has been served—Botero—recently filed for Chapter 13 personal bankruptcy in Arizona, *In re Botero*, Case No. 2:09-bk-33429-SSC, and the Receiver, acting through Larkins Vacura, has made contact with the bankruptcy trustee assigned to this case and is considering to what extent to participate in this proceeding. One of the entity defendants against whom default has been entered also just filed for Chapter 11 bankruptcy in Arizona, *In re BioAuthorize, Inc.*, Case No. 2:10-bk-03505-GBN, and the Receiver is considering his options in relation to this proceeding as well.

#### **IV. THE FEES ARE REASONABLE AND SHOULD BE ALLOWED**

Larkins Vacura believes the present Application is fair and reasonable and that the requested fees and costs incurred have been necessary. The resistance of some of the defendants to the Third Party Litigation has been aggressive, resulting in motion practice over personal jurisdiction. Three of the defendants have sought bankruptcy protection, which has increased the expense of the Third Party Litigation. And some of the defendants have been served and defaulted, which represents progress and sets the stage for pursuing those defendants’ assets.

As shown on the timekeeper summary, Exhibit B to this application, the blended rate at

which Larkins Vacura has provided services during the First Interim is \$258.58, below the Court's limit.

**V. CONCLUSION**

In light of the foregoing, the Receiver and Larkins Vacura respectfully request an order as follows:

1. Allowing and authorizing the Receiver to pay Larkins Vacura LLP \$66,118.00 for legal services during the First Interim;
2. Allowing and authorizing the Receiver to pay Larkins Vacura LLP \$5,107.62 for costs during the First Interim; and
3. For such relief as the Court deems appropriate.
