INTRODUCTION

Plaintiff State of North Carolina, acting on relation of its Attorney General, Roy Cooper, brings this action against defendants alleging that they have violated North Carolina's Telephone Solicitations Act, N.C. Gen. Stat. § 75-100, et seq., and other statutes by making or causing to be made telephone solicitation calls to North Carolina residents whose telephone numbers appear in the national "Do Not Call" Registry, by making or causing to be made telephone solicitation calls via an automatic dialing, pre-recorded message system, and by interfering with individual North Carolina residential telephone subscribers' rights to request not to be called again. Plaintiff seeks temporary, preliminary and permanent injunctive relief, civil penalties, and attorneys fees.

## PARTIES

1. Plaintiff is the State of North Carolina, on relation of Roy Cooper, its Attorney General, who brings this action pursuant to authority found in Chapters 66, 75 and 114 of the North Carolina General Statutes.

2. Defendant United Savings Center, Inc. (hereinafter, "USC") is a Washington corporation which has its principal place of business in Tacoma, Washington. Upon information and belief, defendant USC does business throughout North America under the name Mutual Consolidated Savings and the acronym "MCS."

3. Defendant Possibilities Unlimited, LLC, is an Illinois limited liability corporation which has its principal place of business in Arlington Heights, Illinois.

4. Upon information and belief, both defendants have done business together in North Carolina using the names Mutual Consolidated Savings, MCS, Card Services, Card Holder Services and Credit Card Services.

## FACTUAL BACKGROUND

5. For the past several years, defendant USC has marketed credit cards, debt consolidation and other credit services to consumers via unsolicited telephone calls.

6. Beginning in 2006, defendant USC contracted with and utilized defendant Possibilities Unlimited to place automatically dialed, prerecorded telephone messages to consumers' telephone numbers throughout North America offering defendant USC's services.

7. Defendant Possibilities Unlimited's above mentioned prerecorded message services, referred to in the telemarketing industry as "voice broadcasting services," typically involve the placement of pre-recorded calls to consumers which, following an initial pitch, offer the call recipients the options of either speaking with a live operator for further information or

registering a request not to be called again. The call recipient elects one of these options by pressing a particular number on his or her telephone.

8. If a call recipient elects to receive further information from the defendants and presses the number specified in the recording, he or she automatically is connected to a live sales representative for defendant USC.

9. Defendants have transmitted the aforesaid prerecorded telephone solicitations to North Carolina residential telephone subscribers whose numbers are listed in the national Do Not Call Registry.

10. Upon information and belief, defendants have blocked or prevented the transmission of their true caller identification information, thereby frustrating individual North Carolina residential telephone subscribers' abilities to screen their incoming calls.

11. It is defendants' regular practice not to have a live operator on the line at the beginning of the unsolicited call to state the nature and length of the prerecorded message and to ask whether the telephone subscriber wishes to hear it.

12. Defendants' prerecorded messages do not provide defendants' identities or give telephone numbers or mailing addresses through which the defendants might be contacted.

13. As shown by the attached affidavits of Marian Loy of Kure Beach, Virginia Howerton of Summerfield, Henry Sommerville of Durham, Barry Engber of Raleigh and Thomas Attaway of Raleigh (Plaintiff's Exhibits 1 through 5, respectively) defendants' live telephone solicitors, once they come on the line, often refuse to provide information to North Carolina consumers who ask them to identify their company or give contact information and, in many cases, abruptly hang up.

14. As shown by their attached affidavits, Sam O. Horton of Winston-Salem, Beverly

Lineback of Clayton, Julia Rahmes of Wake Forest (Plaintiff's Exhibits 6 through 8, respectively) and many of the fifteen consumers whose written complaints to the North Carolina Attorney General's Consumer Protection Division are attached (Plaintiff's Exhibits 9 through 23), defendants' live sales representatives regularly give conflicting identification information about who they represent and many times simply offer generic names such as "card services," "card holder services" or "card member services" and little more.

15. Defendants have continued to call individual North Carolina residential telephone subscribers even after those subscribers have pressed the prescribed button on their telephones and or otherwise directly registered their desires not to be called again, as shown by Plaintiff's Exhibits 8, 10, 11, 23 and 24.

16. Neither defendant registered itself as a telephonic seller with the North Carolina Secretary of State prior to placing telemarketing calls to North Carolina residential telephone numbers.

17. Defendant USC recently advised plaintiff that it had discontinued its business relationship with defendant Possibilities Unlimited and was no longer placing any telephone solicitation calls to North Carolina numbers.

18. Upon information and belief, defendant Possibilities Unlimited continues to place "voice broadcasting" calls to North Carolina numbers for other telemarketing clients.

19. Defendants' above alleged telemarketing practices have been conducted knowingly and deliberately.

20. Defendants' above alleged telemarketing practices have been in commerce in North Carolina and have had a substantial and negative impact thereon.

FIRST CLAIM FOR RELIEF: VIOLATIONS OF THE NORTH CAROLINA TELEPHONE SOLICITATIONS ACT: N.C. GEN. STAT. § 75-100 et seq.

21. Plaintiff incorporates herein by reference paragraphs one through twenty, above, and alleges further that defendants knowingly and repeatedly have violated the North Carolina Telephone Solicitations Act, N.C. Gen. Stat. § 75-100 et seq. by virtue of each and all of the following:

- a. By sending prerecorded solicitations to North Carolina residential telephone subscribers who registered their telephone numbers with the national "Do Not Call" Registry more than thirty days earlier;
- b. By conveying unsolicited prerecorded telephone messages via automatic dialing and recorded message players without first employing a human operator who states the nature and length of the recording and then asks the called party whether he or she is willing to listen to it; and
- c. By failing or refusing to honor North Carolina residents' requests not to receive defendants' telephone solicitations again, manifesting a failure to adopt in-house systems and procedures designed to prevent further calls to persons who have asked not to be called again.

22. Defendants' telemarketing practices also demonstrate multiple violations of the Federal Trade Commission's Telemarketing Sales Rule, which is incorporated into North Carolina law by N.C. Gen. Stat. § 75-102(e), as evinced by:

- a. Their failure to transmit or cause to be transmitted defendants' corporate names by caller identification system, thereby obstructing consumers' ability to screen out unwanted telemarketing calls; and

- b. Their direct interference with North Carolina residential telephone subscribers' right to request not to be called again by not providing any opportunity for an individual telephone subscriber to make a Do-Not-Call request without first calling a long distance phone number or listening to multiple prerecorded sales pitches.

SECOND CLAIM FOR RELIEF: VIOLATION OF THE TELEPHONE SOLICITOR  
REGISTRATION AND BONDING ACT, N.C. GEN. STAT. §66-260 et seq. AND THE  
UNFAIR AND DECEPTIVE TRADE PRACTICES ACT, N.C. GEN. STAT. § 75-1.1. et seq.

23. Plaintiff incorporates herein by reference paragraphs one through twenty-two, above, and alleges further, without prejudice to its First Claim for Relief, that defendants' never registered themselves as Telephonic Sellers, as required under North Carolina General Statutes § 66-260, *et seq.* Violations of that statute constitute *per se* violations of the Unfair and Deceptive Trade Practices Act, N.C. Gen. Stat. § 75-1.1 *et seq.* and entitle plaintiff to all remedies that it might receive under that Act, including those prayed for below.

REQUEST FOR TEMPORARY RESTRAINING ORDER  
AGAINST DEFENDANT POSSIBILITIES UNLIMITED

As established by this verified Complaint and the attached affidavits and other exhibits, including affidavits executed in recent days and submitted by Bruce Sloan of Cary and William Oldham of Sanford (Plaintiff's Exhibits 24 and 25), defendant Possibilities Unlimited's violations of North Carolina law are widespread and have not ceased. A Temporary Restraining Order under N.C. Gen. Stat. §§ 75-14 and 105(a) is necessary to prevent further violations of law and further annoyance and harm to the privacy of residential telephone subscribers of North Carolina.

WHEREFORE PLAINTIFF RESPECTFULLY PRAYS THE COURT FOR THE FOLLOWING RELIEF:

1. That defendant Possibilities Unlimited, its owners, officers, agents, telemarketing subcontractors, employees, representatives, successors, assigns, and all others acting in concert with that company with knowledge of this action, be temporarily restrained under N.C. Gen. Stat. §§ 75-14 and 75-105(a) from conducting telephone solicitations in North Carolina until such time as said defendant's telemarketing programs fully comply with all North Carolina and federal telemarketing laws and regulations, including but not limited to N.C. Gen. Stat. §§ 75-102 and 75-104.
2. That, upon proper notice to defendant Possibilities Unlimited and within ten days, a hearing be conducted to determine whether the Temporary Restraining Order, or any reasonable modification thereof, should not be continued in the form of a preliminary injunction pending the final adjudication hereof, as provided in N.C. Gen. Stat. §§ 75-14 and 105(a) and Rule 65 of the Rules of Civil Procedure.
3. That, upon final adjudication hereof, defendants and their owners, directors, officers, agents, telemarketing subcontractors, employees, representatives, successors, assigns, and all those acting on their behalf be permanently enjoined from resuming telephone solicitations that violate North Carolina or federal telemarketing laws and regulations;
4. That, for violations of the Telephone Solicitations Act, N.C. Gen. Stat. § 75-100, et seq., arising from defendants' telephone solicitations to North Carolina residential telephone subscribers, defendants be required to pay civil penalties to the State in the amount of \$500 for the first violation, \$1000 for the second violation, and \$5000 for third and subsequent violations thereof, pursuant to N.C. Gen. Stat. § 75-105(a).
5. That, for violations of the Telephonic Sellers Registration Act separate and

distinct from those mentioned in paragraph "4" immediately above, defendants be required to pay additional civil penalties to the State in the amount of \$5000 per violation of the said Act and the Unfair and Deceptive Trade Practices Act, pursuant to N.C. Gen. Stat. § 75-15.2, or in the amount of \$5000 for each week their practices persisted, as allowed by N.C. Gen. Stat. § 75-8, whichever results in the higher penalty;



I registered my phone number on the Do Not Call list on June 28, 2003.

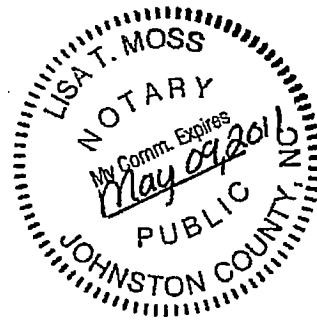


