Diana K. Carey, chapter 11 trustee for the estates of the above named debtors (“Trustee”), hereby files this reply in support of her Motion for Order Allowing and Authorizing Payment of Certain Priority Unsecured Claims (“Motion to Allow”), and her Omnibus Objection to Claims Seeking Priority Pursuant to 11 U.S.C. § 507(a)(6) (“Omnibus Objection”). In support thereof, the Trustee states as follows:

1) Attached to this Reply as Exhibit A is the list of those individuals whose claims the Trustee has moved to allow, pursuant to her Motion to Allow, filed in this case on April 17, 2006, at Docket No. 810. Some of the names on Exhibit A are creditors with claims the Trustee originally included in her Omnibus Objection. After receiving these creditors’ responses, the Trustee has withdrawn her objection and seeks to allow and authorize payment of these claims as

1 well.

2 2) Attached to this Reply as Exhibit B is a list of individuals to whose claims the  
3 Trustee has objected. The claimants on Exhibit B were mailed notice of the Trustee's objection  
4 on April 17, 2006, and have either failed to respond to the Trustee's objection, have filed  
5 duplicate claims, or have voluntarily withdrawn their claims. For those claimants who have filed  
6 duplicative claims, the Trustee has allowed one claim and objected to the duplicate.

7 3) Attached to this Reply as Exhibit C is a list of five individuals whose claims the  
8 Trustee seeks to resolve via a specially set hearing. The Trustee included four of these claims in  
9 her Omnibus Objection, and the claimants have filed timely responses thereto. One of these  
10 individuals filed an objection to the Trustee's Motion to Allow. The Trustee has been unable, at  
11 the time of filing this Reply, to resolve her objection or issues with these particular claims. The  
12 Trustee requests a telephonic hearing be set to specifically address the claims of each of these  
13 five individuals. The Trustee has requested a telephonic hearing to allow these individuals to  
14 preserve their claims and objections, yet being mindful of the small amount of the claims and the  
15 distance by which these claimants would have to travel to appear in person in Seattle. The  
16 Trustee believes these claims and objections have no merit, but does not want to deprive these  
17 claimants the opportunity to be heard if they so desire.

18 Therefore, the Trustee respectfully requests this Court allow and authorize payment of  
19 those claims listed on Exhibit A, disallow those claims listed on Exhibit B, and set a date for a  
20 telephonic hearing to address those five claims listed on Exhibit C.
